We would like to inform you that this is in continuation of our intimation dated 31st January 2025 regarding the commencement of full-scale operations at its new state-of-the-art mega die-casting facility at Thervoy Kandigai Plant (TKP), Chennai.

As part of the Company's ongoing consolidation strategy and in an effort to optimize production flow and incorporate cutting-edge technology, the Board of Directors at their meeting held today i.e., 6th May 2025, approved the proposal to relocate all machining activities from the Mahindra World City Plant (MWC Plant), located in Chengalpattu Taluk, Kancheepuram District, to the Company's other plants located in Thervoy Kandigai and Oragadam, subject to necessary approvals of the Statutory Authorities.

This strategic move is expected to streamline operations, reduce operational costs, and enhance production efficiency by leveraging the advanced technological infrastructure available at the Thervoy Kandigai and Oragadam plants.

Necessary details as required under the Listing Regulations, read with SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155, dated 11 November 2024, are provided in Annexure I.
